GUILFORD TOWNSHIP TRUSTEES DIRECTED LIABILITY AGREEMENT FOR USE OF THE GUILFORD TOWNSHIP HALL

I, the undersigned is 21 years or older, understand that the Guilford Township Hall will be reserved for use for a fee of \$80.00 for one floor (basement or main floor), \$125.00 for both floors, under the following conditions which I agree to observe. *There will not be a rental fee for township residents who choose to use hall for a funeral dinner or gathering.*

Please read and initial the following items:

- 1. No alcohol, smoking or vaping is allowed on the premises.
- 2. No tape on walls, pipes, chairs or tables. No glitter.
- 3. No pets allowed; however, animals needed for medical reason are permitted.
- 4. No commercial fund raising is permitted; however, nonprofit groups are excluded from this restriction.
- 5. The Guilford Township Hall must be vacated by midnight on the date reserved by the undersigned. Please lock all windows, doors and EXIT through the back door(s) by the parking lot.
- 6. The reserving individual is responsible for the cleanup procedures of cleaning tables and chairs, sweeping the floor and all trash to be removed from the Guilford Township property. Please check bathrooms for cleanliness.
- 7. The undersigned lessee/renter agrees to pay for any damage to the Guilford Township Hall building and/or Township property and also agrees to pay replacement costs for any missing items. In addition, the undersigned individual agrees to pay a \$20/hr. cleanup cost if the Guilford Township Hall and/or Guilford Township property is left in unsatisfactory condition.
- 8. Individuals causing harm to Guilford Township Hall property may be denied use of the facilities in the future, at the discretion of the Guilford Township Trustees.
- 9. The undersigned understands and hereby acknowledges that the Board of Guilford Township Trustees shall not be responsible and/or liable for personal injury, for property damage occurring to persons and/or their guests and invitees while using the Guilford Township Hall for their own personal matters and/or for matters unrelated to the business of the Board of Guilford Township Trustees.
- 10. The undersigned understands and hereby acknowledges that the Board of Guilford Township Trustees shall not be responsible for any personal property left behind or stored within the Township Hall or on Township property.

The undersigned releases and discharges the Board of Guilford Township Trustees or Township Representative from any liability, claims, demands, injuries, damages, actions or causes of action that might occur arising from the use of the Guilford Township Hall and activities conducted on Guilford Township property.
